












Fig. 7. $V_{CC} = 2.0 \text{ V}; I_O = 0 \text{ A}$





 $V_{CC} = 5.5 \text{ V}; I_{O} = 0 \text{ A}$




Fig. 10. Test set-up for measuring forward transconductance $g_{fs} = \Delta I_O / \Delta V_I$ at V_O is constant





Fig. 11. Typical forward transconductance g_{fs} as a function of the supply voltage at T_{amb} = 25 °C






Fig. 14. Package outline SOT353-1 (TSSOP5)




Fig. 15. Package outline SOT753 (SC-74A)
