# Low-power dual 2-input EXCLUSIVE-OR gate

### 1. General description

The 74AUP2G86 provides the dual 2-input EXCLUSIVE-OR function.

Schmitt trigger action at all inputs makes the circuit tolerant to slower input rise and fall times across the entire  $V_{CC}$  range from 0.8 V to 3.6 V.

This device ensures a very low static and dynamic power consumption across the entire  $V_{CC}$  range from 0.8 V to 3.6 V.

This device is fully specified for partial power-down applications using  $I_{OFF}$ . The  $I_{OFF}$  circuitry disables the output, preventing a damaging backflow current through the device when it is powered down.



# 5. Functional diagram









Fig. 6. The data input (nA or nB) to output (nY) propagation delays




Fig. 8. Package outline SOT765-1 (VSSOP8)




Fig. 9. Package outline SOT833-1 (XSON8)




Fig. 10. Package outline SOT1116 (XSON8)




Fig. 11. Package outline SOT1203 (XSON8)
