







Fig.4 DC Current Gain vs. Collector Current(II)



## ● Electrical characteristic curves(T<sub>a</sub> = 25°C)




Fig.5 Collector-Emitter Saturation Voltage vs. Collector Current(I)

# Fig.7 Base-Emitter Saturation Voltage vs. Current





Fig.8 Gain Bandwidth Product vs. Emitter


