Soldering:

- The solder profile must comply with the Würth Elektronik technical soldering specification. All other profiles will void the warranty.
- All other soldering methods are at the customers' own risk.

Cleaning and Washing:

- Washing agents used during the production to clean the customer application may damage or change the characteristics of the
 optoelectronic component body, marking or plating. Washing agents may have a negative effect on the long-term functionality of the
