### Typical Insertion Loss:



## Derating Curve:

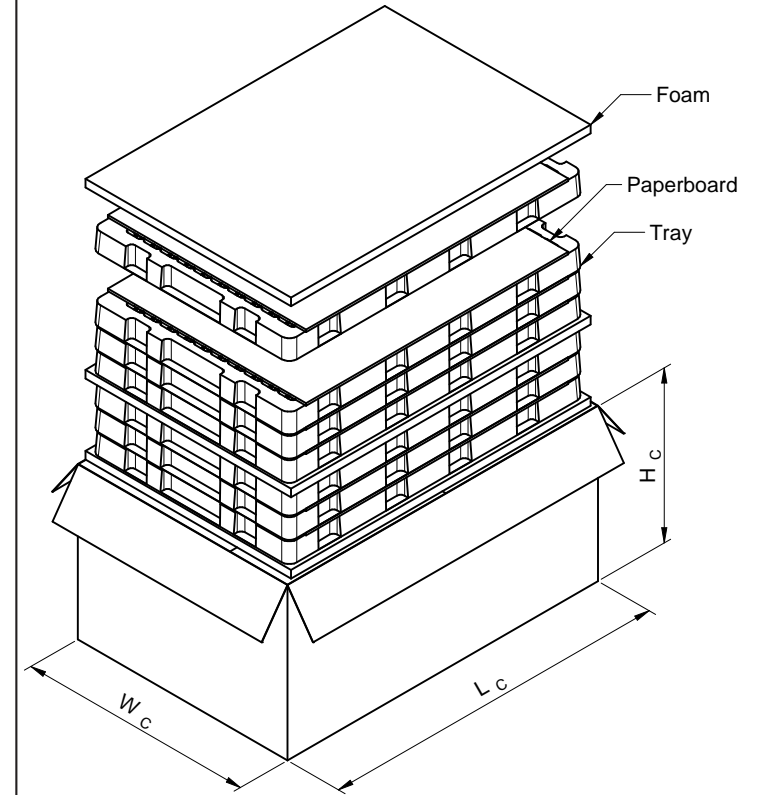

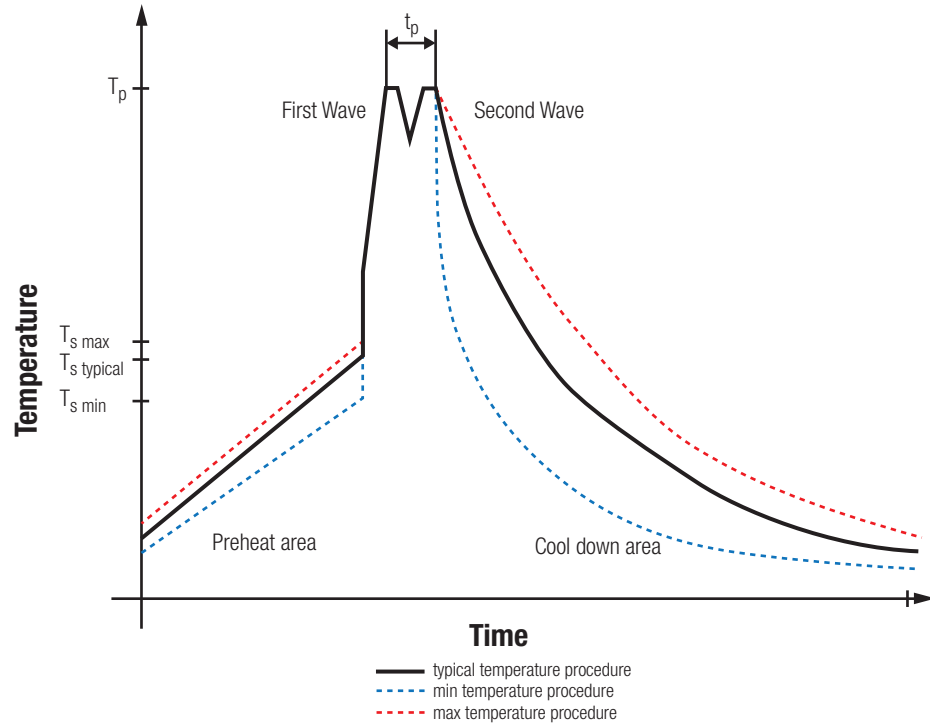

#### Soldering:


