### Typical Insertion Loss:




### Typical Impedance vs. Frequency:

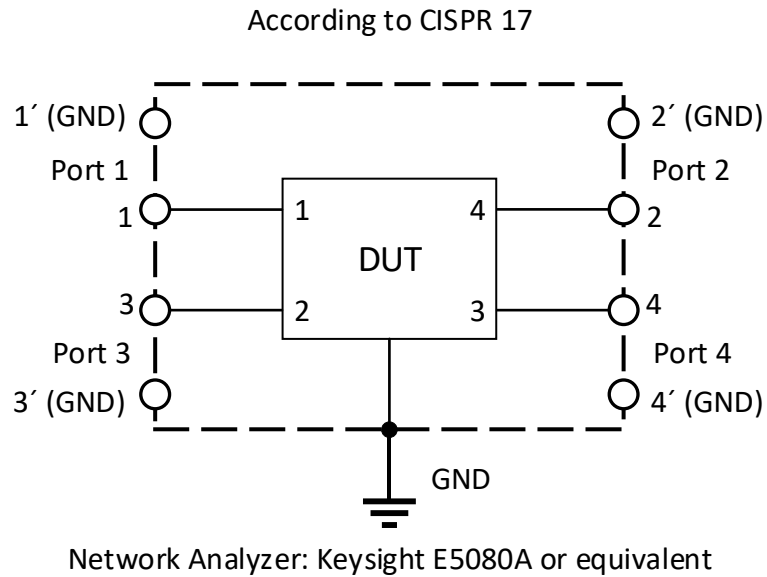

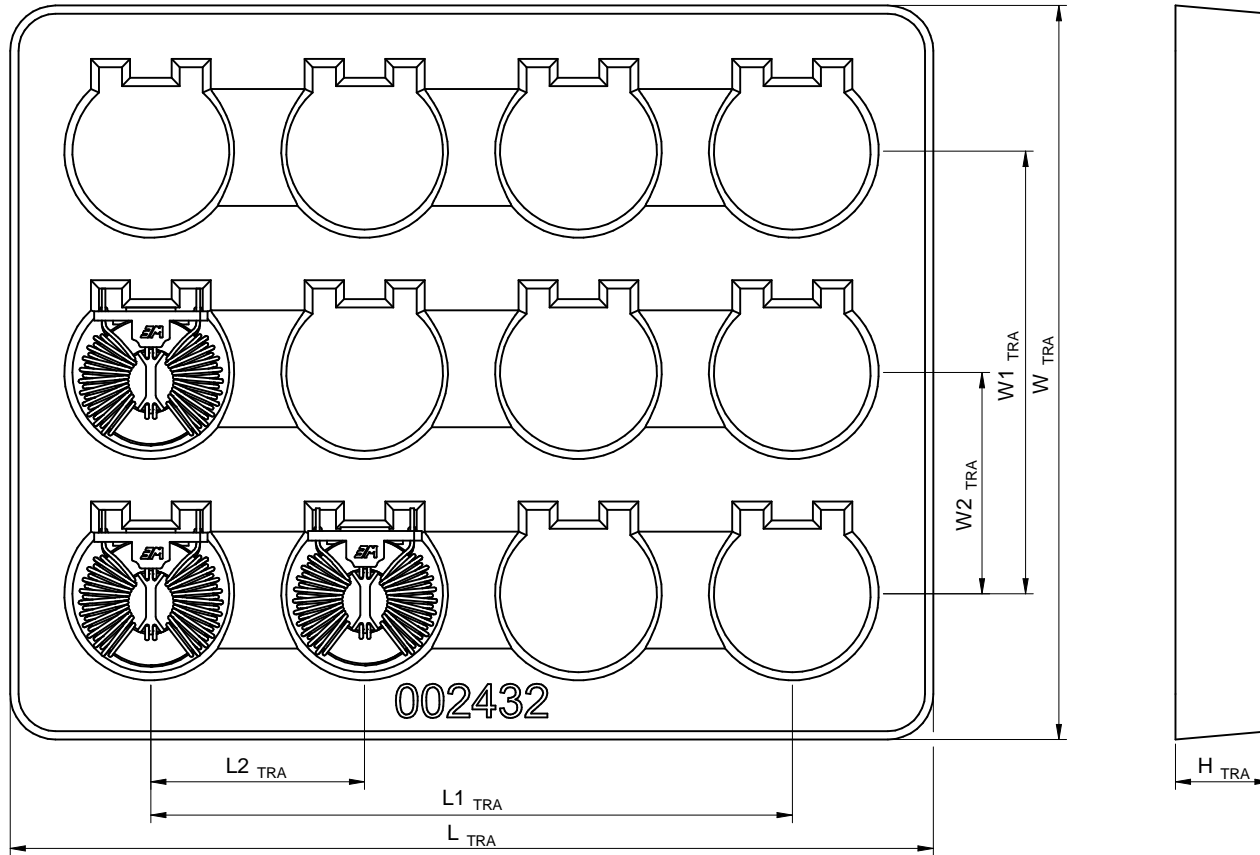
