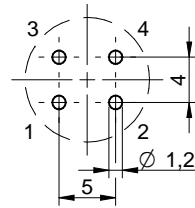


### sectional drawing A-A

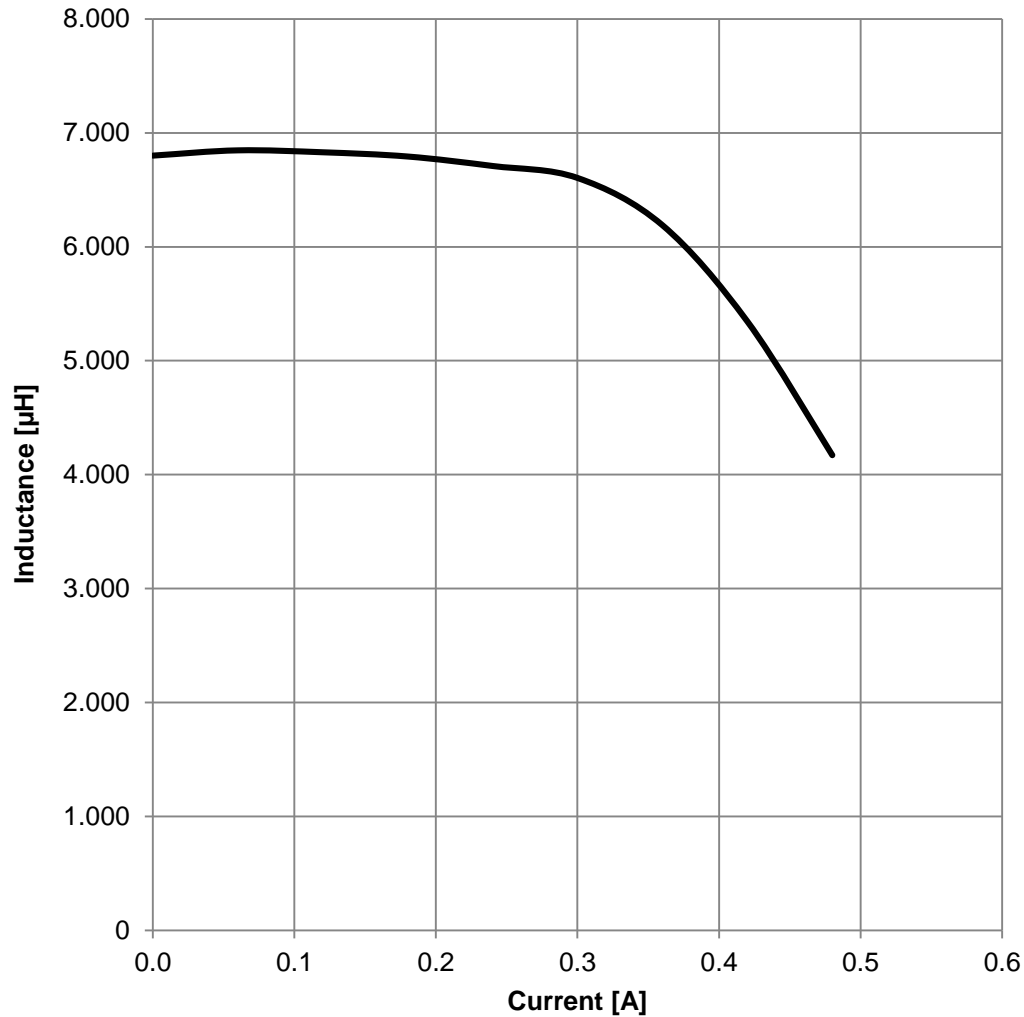

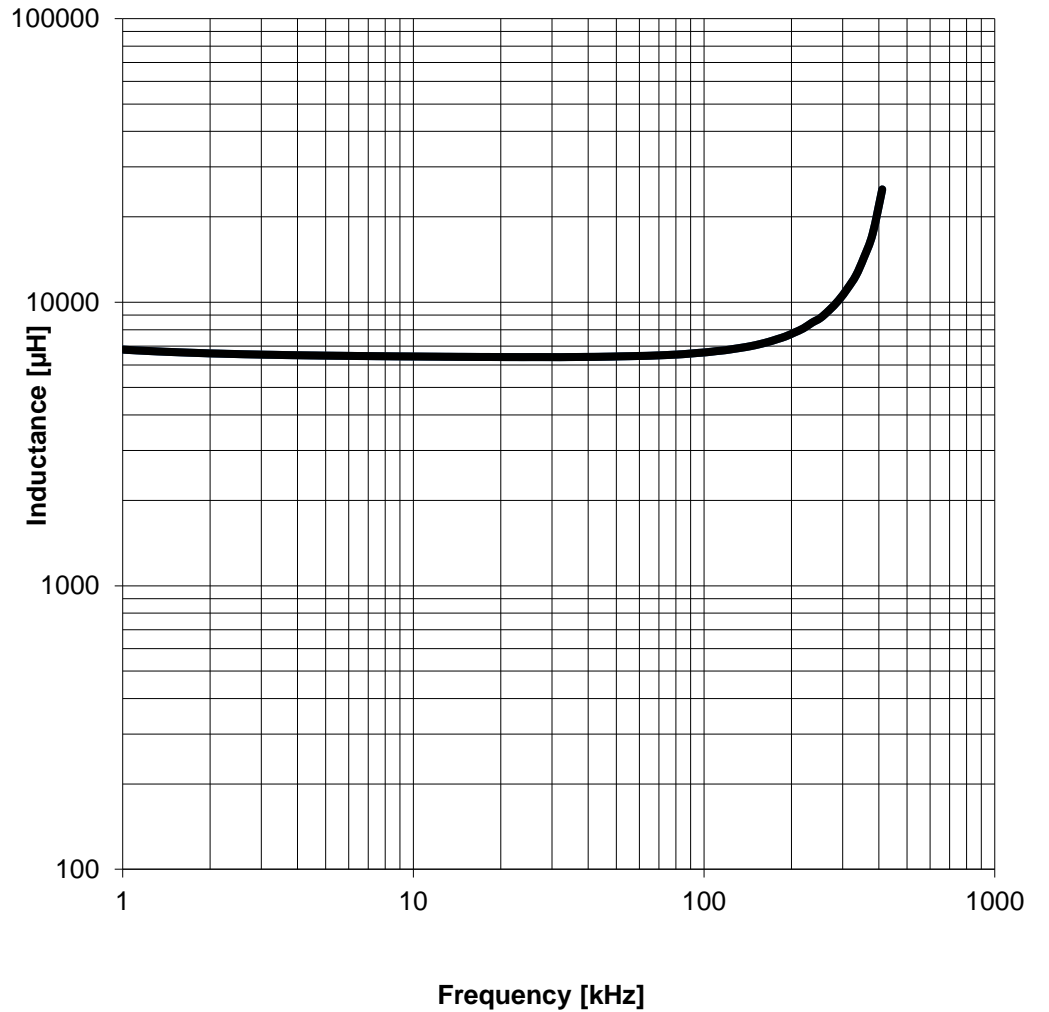

### Typical Inductance vs. Frequency Characteristics:

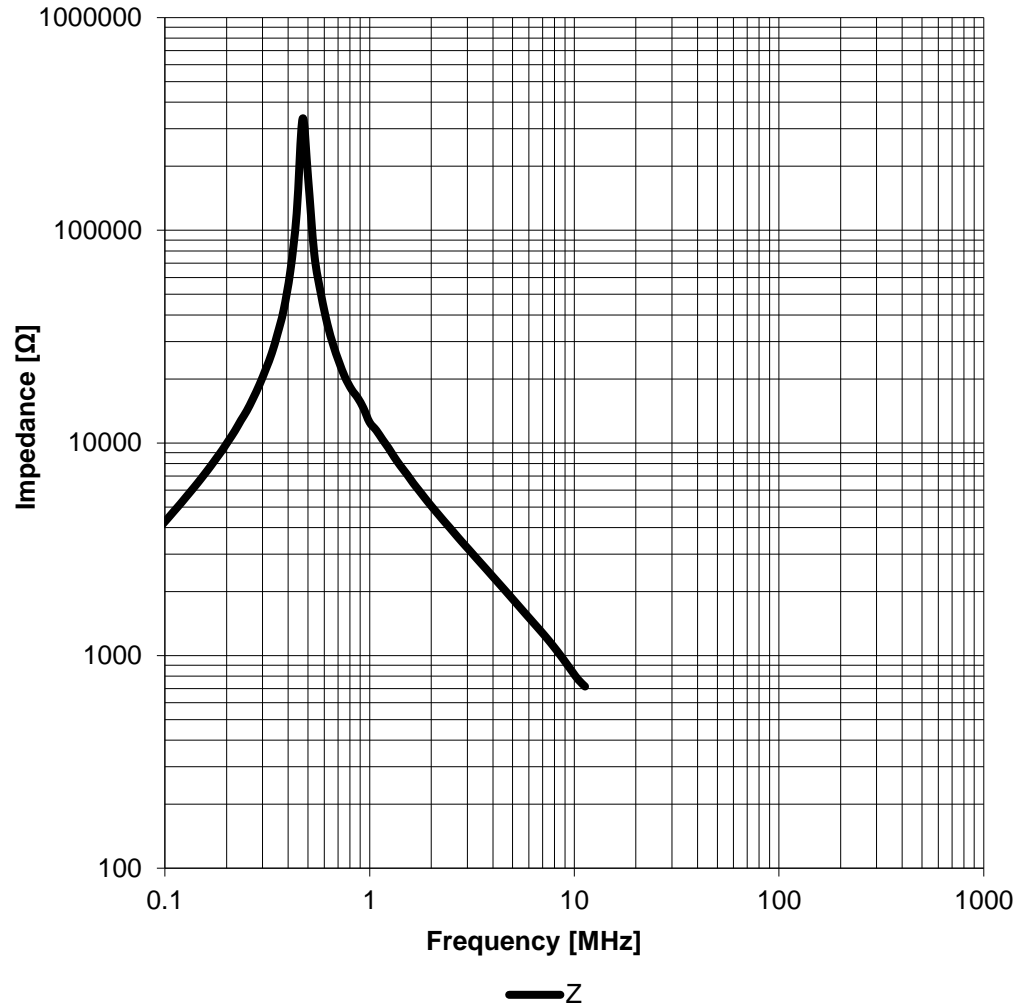









## Storage Conditions:


