
Luminous intensity is tested at a current pulse duration of 25 ms and an accuracy of \pm 11 %.





Fig. 2 - Relative Intensity vs. Angular Displacement

Fig. 3 - Relative Intensity vs. Wavelength




Fig. 4 - Forward Current vs. Forward Voltage




Fig. 5 - Relative Luminous Intensity vs. Forward Current




Fig. 6 - Change of Dominant Wavelength vs. Forward Current




Fig. 7 - Change of Forward Voltage vs. Ambient Temperature




Fig. 8 - Relative Luminous Intensity vs. Ambient Temperature





Fig. 9 - Change of Dominant Wavelength vs. Ambient Temperature
