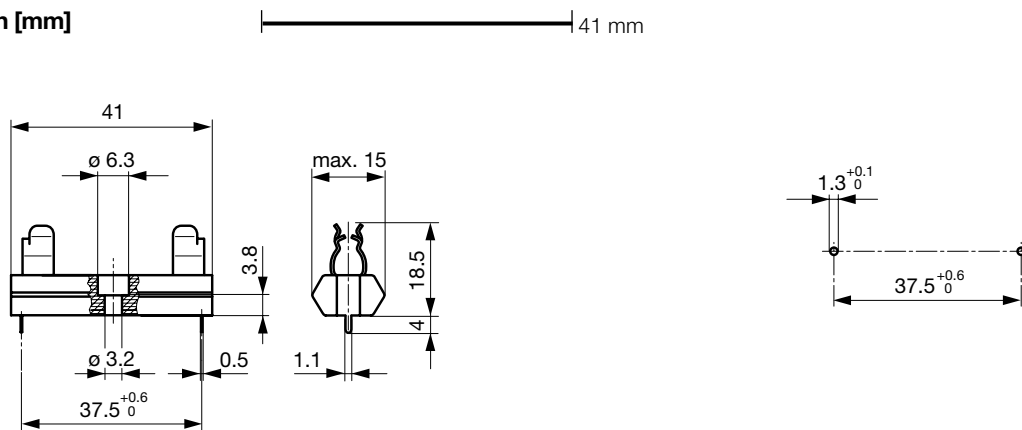

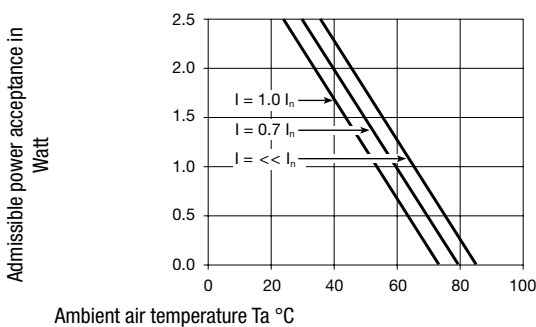
## Dimension [mm]
