#### **Notes**

- Chromaticity coordinate groups: Chromaticity coordinate groups are measured during a current pulse duration of typically 10ms with a tolerance of ±0.005.
- Typical Values: Due to the special conditions of the manufacturing processes of semiconductor devices, the typical data or calculated correlations of technical parameters can only reflect statistical figures. These do not necessarily correspond to the actual parameters of each single product, which could differ from the typical data and calculated correlations or the typical characteristic line.
